The appointment of a provincial government mediator in the southern Interior of B.C., averted a strike just one day before the contract was due to expire.

By law in B.C. there cannot be a legal strike or lockout for the next 10 days while mediator F.R. Freeborne meets with the IWA and the Interior Forest Labor Relations association representing 40 major manufacturers in the Southern Interior.

Crown Zellerbach Canada Ltd., has announced a \$25 million, two year program to modernize and build new sawmills at their Interior operations.

Vol. 22 No. 14 \ July 7, 1972 First results from the B.C. coast IWA vote to end the strike of 28,000 members indicate acceptance by a slim majority.

The 6,500 Vancouver local of the IWA voted 59 per cent in favor of a 73 cent hourly wage increase over two years.

Fallers who have been on a wild cat strike since mid April will take a secret ballot of their own on the settlement,

Balco Industries Ltd., of Kamloops B.C. reported a 70% increase in sales for the six months ended May 31 compared with the same period in 1971.

The IWA voted by a margin of 53.2 percent to accept FIR's offer of a 19 percent wage increase. FIR decided to delay signing the contract because 10 of its members had not settled local issues with the union.

Meanwhile, the fallers who have been on a wild cat strike since mid April continued to buck - not logs - but the terms of the new agreement.

Boise Cascade Corporation announced it may have to write off \$175 to \$200 million of its investments in various recreational land projects.

Under terms of the new contract the 6,000 woodworkers will achieve
parity with the B.C. coast within the two year contract.

On the B.C. coast the fallers dispute continues. According to Forest Industrial Relations about 275 of the 800 coast fallers who went on an unofficial strike in mid April have returned to work.

The reimposition of U.S. price controls for companies with gross sales of \$100,000 up resulted in a temporary buying slow down in some rail areas this week.

Douglas Grant, lumber salesman and pilot for the Millar Lumber & Coal Co. Ltd., of Edmonton, Alberta was killed in a recent plane crash at Chetwynd, B.C.

IWA officials in Vancouver told some 500 dissident fallers at B.C. coast mills to get back to work or quit. The fallers are refusing to accept the new \$80.52 a day base rate for a six and a half hour day.

Log shortage has shut down the MacMillan Bloedel Alberni Pacific division resulting in a layoff of 400 men. The Somass "A" mill at Port Alberni will shut down Aug. 2 if the log shortage continues. Another 475 men will be out of work.

Crown Zellerbach Canada Ltd., reported sales for the first six months of this year were \$113.5 million compared with \$93.5 million in the same period last year. Net income before extraordinary items was \$5.9 million compared with \$3.6 million.

The wild cat fallers strike on the B.C. coast continues, although more fallers are back at work. Approximately 500 of the 800 fallers are now reported working compared to 300 last week.

There have been mill shutdowns on the B.C. coast this week caused by pickets from dissident groups. The fallers still on strike are trying to shut down all logging operations and mills on the B.C. coast.

North Canadian Lumber Company a subsidiary of Canadian Forest Products has acquired the timber and assets Ken A Mitchell Sawmills Ltd., in northern Alberta.

Weldwood of Canada Limited reported net income for the second quarter of this year at \$2,273,000 compared with \$1,047,000 for the same period last year.

British Columbia Forest Products Ltd., reports net earnings of \$4.7 million for the first half of this year compared with \$2.4 million for the same period in 1971. Sales totalled \$80 million.
